## Types of Memberships at Nittany Country Club:

Basic Membership: The cost of this membership is \$300.00 (\$100.00 dues and \$200.00 assessment). This is a family membership with one vote and includes the use of the dining facilities, the use of the pool and allows the family to select the appropriate golf assessment. If the member does not elect to take a golf assessment, they may play twice during the golf season, paying green fees for each round. The only other golf privileges they have would be at the same times and fees as the public.

### Golf Assessments:

- Family one (1) golfer - \$950.00 per year, plus Basic Membership
- Family two (2) golfers - \$1400.00 per year, plus Basic Membership.
- Family three (3) or more golfers - \$1400.00 per year, plus \$200.00 per year for additional golfers, capped at \$1900.  
(Dependents 12 years of age and under are free.)

Non-residents >75 miles: Cost is \$300, with unlimited golf. This membership is for a person living more than 75 miles from Mingoville, whose legal place of residence is not within Centre County or a county contiguous thereto.

Junior Golf Privileges: \$200.00 per year. This golf privilege consists of a person 18 years of age and under, who is not part of any member's immediate family. This class of membership carries through the summer following their graduation from High School and allows the Junior unlimited use of the golf course.

Dining Privileges: \$100.00 per year. Allows use of dining facilities

First Year Membership: \$950.00, \$150 due with application, with \$400 billed in April and \$400 in July. A one-time offer that entitles the new member and his/her family to use the dining facilities, the pool and the golf course for the first year.

### **Note:**

*Membership fees are a calendar year commitment. They may be paid in full, or for the members convenience, billed quarterly. Dues are billed quarterly on the first day of the quarter. Dining and Non-Residents are billed annually on January 1<sup>st</sup>. All bills are due within 30 days of the date billed. Junior membership fee is due with application*
